1. On 2/3/2020, State of Alaska, Division of Elections, and Gail Fenumiai, Director, filed an appeal of Judge Aarseth's final order distributed on 1/29/2020. On 2/3/2020, Stand Tall With Mike filed an appeal of the same order. These appeals are related and will be consolidated for purposes of briefing, argument, and decision. The caption in this case will be as shown above. This appeal is not subject to the requirements of Appellate Rule 221. This appeal will be handled on an expedited basis, as noted below.

2. The notice of completion of preparation of file is due from the Appellate Court Records Office (ACRO) on or before **2/21/2020**. The record in this appeal will include only the documents and proceedings in the trial court case referenced above.

3. It is the responsibility of Stand Tall With Mike's transcriber to ensure that all transcripts designated by any party are received by the court on or before **2/21/2020**. The Appellant's transcriber must file one unbound condensed copy and an electronic version of the transcript in the form and format prescribed by the Manual of Transcript Procedures.

Appellee's Brief: **03/09/2020 (12:00PM)**

Reply Briefs: **03/17/2020 (12:00PM)**

Initial briefs under Appellate Rule 212(a)(1) are not required. Instead, the briefs should be submitted in printed and bound format on the above due dates. The covers do not need the Clerk's signature, but should follow the usual convention for colors (Ivory - Blue - Green, and Pink for excerpts). The Clerk's Office requires ten (10) printed copies of briefs and eight (8) printed copies of excerpts, if any, as well as an electronic, pdf version emailed to the undersigned.

5. Oral argument will be held at 1:30PM on Wednesday, **3/25/2020**.
