**NOTICE OF NON-OPPOSITION AND PARTIAL JOINDER IN BOARD'S  
MOTION FOR RECONSIDERATION**

Appellants Matanuska-Susitna Borough and Michael Brown (collectively hereinafter referred to as "MSB"), by and through their counsel of record, Holmes Weddle & Barcott, P.C., hereby file this Notice of Non-Opposition and Partial Joinder in Board's Motion for Reconsideration.


MSB agrees that AS 22.05.010 governs this matter. The legislative history makes clear that the decision to allow parties to appeal directly from the superior court was the result of substantive consideration and negotiation.<sup>1</sup> Particularly with regard to the MSB, the decision issued by the superior court is final. There are no matters remanded that will impact the 40 district map. Realistically, if the Board were to change the boundaries between Districts 3 and 4 on remand, it would only impact those districts. Therefore, the

decision regarding the MSB was final. Furthermore, the efficiency of consolidation is frustrated if appeal is not allowed, because the result could be multiple remands.
