The Reply brief submitted on **10/78/2019** in the above case has been **conditionally accepted**. Please make the following changes before printing the brief.

1. There is no certificate of font certifying that the non-Courier font used is 13 pt. and one of the acceptable serif fonts. (Appellate Rule 513.5(c))
2. The cover of the brief does not include counsel's bar number, though page 9 of the brief does contain this number. (Appellate Rule 212(b))
3. The cover of the brief does not contain the case number below --- ABA File No. 2018R002. I notice that Mr. Brion's opening brief also does not contain this case number. (The Alaska Bar Association's brief does.) (Appellate Rule 212(b))
4. There are some factual assertions that are not supported by a citation to the record. (Appellate Rule 212(c)(1)(I)). Specifically:
  - a. Page 3: Mr. Brion asserts that his witnesses each testified that he was competent to practice law, that he was morally and ethically fit to do so, and that he should be reinstated. He does not indicate where in the record or transcript of the hearing his witnesses claimed this.
  - b. Page 6: Mr. Brion restates an argument he made in his opening brief. This could benefit by a citation to the page number of his opening brief where he makes the argument originally.
  - c. Page 6: Mr. Brion refers to his plan for a three year mentorship. This could benefit by a citation to the record where he stated this plan.

- d. Page 6: Mr. Brion asserts that the Area Hearing Committee had several issues with his plan for three year mentorship. This could benefit by a citation to the Area Hearing Committee findings where they detailed their issues with Mr. Brion's plan.
- e. Page 7: Mr. Brion quotes Bar Counsel. This would benefit by a citation to the Bar Association's brief where they make this statement.
